

**CEMETERY PRESERVATION GROUP, INC VOLUNTEER
RELEASE, WAIVER AND INDEMNIFICATION AGREEMENT**

I hereby certify that I have volunteered my services to assist Cemetery Preservation Group, Inc. (CPG) and have agreed to cut grass, trim shrubs, operate weed eaters, blowers etc. and/or pick up trash, limbs and may perform other approved tasks as needed within the cemeteries located in the City of Selma. While performing services hereunder, I agree to take precautions so as not to damage any grave markers, monuments or sentimental decorations located in the work area. I, for myself, my heirs, personal representatives or assigns, do hereby agree not to sue and further release, waive and discharge both CPG and the City of Selma, their elected officials, officers, employees, agents and departments from all liability from any and all claims, demands, actions, causes of actions, damages, punitive damages, personal injury, accidents, illnesses (including death), and property loss arising out from, but not limited to, volunteering to cut grass, trim shrubs, operate weed eaters, blowers etc. and/or pick up trash, limbs within the cemeteries. I also agree to indemnify and hold CPG and the City of Selma, their elected officials, officers, employees, agents and departments harmless from any and all claims, actions, suits, demands, punitive damages and expenses, including attorney fees arising out of or resulting from my involvement, participation and services with CPG hereunder within the cemeteries located in the City of Selma and my damage to any grave markers, monuments or sentimental decorations located therein.

I, the undersigned further expressly agree that the foregoing waiver is intended to be as broad and inclusive as is permitted by the laws of the State of Alabama and that if any provision hereof is held invalid, the remaining provisions shall, notwithstanding, continue in full legal force and effect.

I have read this release, waiver of liability and indemnification agreement and fully understand its terms and understand that I am waiving substantial rights, including my right to sue. I acknowledge that I am signing the agreement freely and voluntarily and intend my signature to be a complete and unconditional release of all liability to the greatest extent allowed by law. I further acknowledge that I am over the age of 19 years and am fully competent to sign this agreement.
